FEE STRUCTURE

- All camp and conference fees are charged on an individual basis and cover lunch and tea breaks, a gift pack, instructors' fees. The Cheer Camp Package also covers the camp competition and party fees.
- Dinner arrangements can be made for those who choose to stay after camp hours for certification courses but at additional costs. Kindly inform us at least two weeks in advance if you require assistance in these or other areas.
- Transportation and accommodation charges have not included in these fees. CHARM is also able to assist in making the arrangements but please note that these additional costs are to be borne by the participant and will vary based on the different service providers.
